Anyone speaking during the Community Forum should first identify themselves by their first and last names for the public record. There is a 3-minute time limit, and large groups interested in the same topic should select a spokesperson. State law prohibits the Court from deliberating on any item not listed on the posted agenda.*) (JDC)

6. Discussion for the purpose of coordination and cooperation for efficiency between precincts. No action will be taken.
7. Discuss plat submittals. Take necessary action. (JDC)
8. Tax Bid Sale. 1.00 acre, more or less, part of the John Jordan Survey, Abstract 457, more particularly described in deed recorded in Volume 346, Page 404, Wise County, Texas.
9. Consider accepting donations of personal property and/or various revenues to County (if any). Take necessary action. (KH)
