Anyone speaking during the Community Forum should first identify themselves by their first and last names for the public record. There is a 3-minute time limit, and large groups interested in the same topic should select a spokesperson. State law prohibits the Court from deliberating on any item not listed on the posted agenda.*) (JDC)

6. Discussion for the purpose of coordination and cooperation for efficiency between precincts. No action will be taken.
7. Discuss plat submittals. Take necessary action. (JDC)
8. Receive and discuss Initial Assessment regarding whether redistricting is required for commissioner precincts considering the new 2020 census data; and, if so, discuss and consider adoption of redistricting criteria to apply to development of new redistricting plans, and guidelines for public participation in the redistricting process. (JDC)
9. Discuss and consider Western Surety Company Official Bond and Oath, (No. 72090474) for Joey Highfill, Public Works Director, County of Wise. Take necessary action. (JDC)
10. Consider accepting donations of personal property and/or various revenues to County (if any). Take necessary action. (KH)
