Clark opened the public hearing at 8:45am, all court members were present.




Clark asked the court to consider the adoption of the proposed FY2024 budget at the next regular meeting of the Commissioners Court on September 11, 2023.



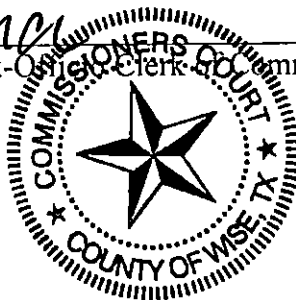
