



**SECOND AMENDMENT TO CONTRACT
AND AGREEMENT**

This SECOND AMENDMENT is effective as of the last date signed by either Party and amends and supplements that certain CONTRACT AND AGREEMENT ("Agreement") fully executed as of August 20, 2018 and FIRST AMENDMENT fully signed and executed as of March 3, 2020 by and between Wise County Sheriff's Office, 200 Rook Ramsey Dr., Decatur, TX 76234 ("Customer") and Correct Solutions Group, LLC., located at 102 Bastille Lane, Ruston, Louisiana 71270 ("CSG").

WHEREAS, Customer desires and CSG agrees to amend the Agreement.

WHEREAS, this SECOND AMENDMENT will become effective as of date signed below by Wise County Sheriffs Office.

NOW, THEREFORE, as of the SECOND AMENDMENT Effective Date, the parties agree as follows:

Part 1, TERM of CONTRACT AND AGREEMENT will be modified to read: "This Agreement is effective on the date signed below by Wise County Sheriff Office ("Effective Date"), and shall continue in effect ("Initial Term") until September 30, 2023. Upon completion of the Initial Term, Customer will have the option to renew this Agreement for a period of 1 year. This Agreement will automatically renew under the terms described as Initial Term unless either party notifies the other in writing of its intent to terminate this Agreement at least 90 days prior to the final date of expiration. Either party has the option to terminate this Agreement for convenience upon 90 days notice. Upon termination of this Agreement, each party agrees to satisfy any and all of its outstanding obligations arising under this Agreement.

ATTACHMENT B of CONTRACT AND AGREEMENT will be amended to include:


TABLETS AND IN-POD KIOSKS

CSG will provide customer with 100 correctional grade inmate tablets and 2 correctional grade in-pod kiosks, 39 Wireless Access Points, 2 24-Port Switches, 39 Two-Base Wall Mounts, 37 Charging Base Blanking Plates and 41 Five-Bay Charging Bases. Services provided by these units will include, but not limited to, electronic messaging, law library, grievance, medical scheduling, commissary ordering. Video visitation will be included for off-site remote connection only.

All terms and conditions of the original Agreement not amended by this FIRST AMENDMENT remain in full force and effect.


